- The candidate should appear for all the papers in the main written examination for his answer sheet to be evaluated and in case the candidate absent himself for one or more papers, the papers attended shall not be evaluated.
- The candidates who seture less than minimum marks prescribed for each paper in the main written examination shall not be sligible to the day comes.
